## NOTES

- 1 This Festival Donations Form and Declaration is for regular monthly or annual donations by Bankers Order ONLY. A separate Form is available for single donations by Individuals, Lodges, Chapters and other Orders and organisations.
- 2 Please DO NOT use this Form when sending Gift Aid Envelopes to the Trust, instead use the Envelope Verification Form and send cheque and empty envelopes direct to the Trust.
- 3 Please ensure that the Bankers Order section of this Form is completed in full and is signed and dated. Do NOT detach this section. After recording the appropriate details it will be sent by the Trust to the Bank for processing.
- 4 The completed Form should be sent to the Royal Masonic Trust for Girls and Boys at 60 Great Queen Street London WC2B 5AZ.
- 5 Details of your donations and RMTGB status will be stored and processed by the Trust in accordance with the Data Protection Act 1998. Donor details will only be shared with Relevant Bodies connected with the Masonic Charities Festival system.
- 6 **Gift Aid Notes**
  - 6.1 The revised Gift Aid system took effect from 6 April 2000.
  - 6.2 Only UK residents (including members of UK Armed Forces and Crown Servants) who are taxpayers should complete the Gift Aid Declaration Section of the Form.
  - 6.3 A Gift Aid Declaration may be made to accompany a single gift (see alternative Form) or a fixed sum monthly or annually typically over a period of years.
  - 6.4 When payments are made to the Trust, income tax is added thereto at the basic rate and the Trust is subsequently able to obtain a refund of this tax from HMRC.
  - 6.5 By making a Gift Aid Declaration you are confirming that **a**) you are a UK resident taxpayer who pays an amount of Income Tax and/or Capital Gains Tax at least equal to the amount the Trust may reclaim on your donation(s), **b**) you undertake to notify the Trust if you no longer pay Income Tax and/or Capital Gains Tax at least equal to the tax we may reclaim on your donation(s), **c**) that you will notify the Trust of any change in your name and address and **d**) that if you have ticked Box 2 in the Gift Aid Section, you want the Trust to reclaim the tax on all donations during the current tax year and the 4 tax years prior to the date of this Declaration.
  - 6.6 If you elect to donate to the Trust under the Gift Aid Scheme by regular Bankers Order, you will receive an initial acknowledgement of your undertaking and thereafter a personal statement at the completion of each tax year.
  - 6.7 Higher rate taxpayers may nominate the RMTGB to receive any additional tax relief due by entering the unique code VAE64YG when completing their Tax Return.
  - 6.8 Until 31 March 2010 claims by Charities for refund of tax on donations were made up to 6 years after the end of the accounting period to which the claim relates. After 31 March 2010 this period was reduced to 4 years.
